### PURPOSE

This course is designed to provide a state-of-the-art update on selected aspects of current pharmacological, surgical and complementary treatment for patients with Heart Failure.

### AUDIENCE

This conference is planned for healthcare professionals including physicians, nurses, nurse practitioners, physician assistants, and pharmacists who manage the care of the heart failure patient.

- 1) Recognize the issues surrounding diuretic dosing in acute heart failure and relate how the results of the Dose trial may influence practice.
- 2) Review the current status of stem cell infusion/transfection in the treatment of heart failure and what the near future may hold.
- 3) Identify the roles of several therapies and diagnostic modalities utilized in managing heart failure.
- 4) Illustrate both the medical and economic importance of early readmissions and recognize the barriers to properly aligned incentives and propose strategies for change.
